IN THE LAST MONTH...

- RHA Board approved and finalized the Relocation Plan
- Heritage Park has brought on 2 new staff members
- 65+ households have completed their relocation surveys
- Approx. 30 Heritage Park families have a Section 8 voucher
- Voucher orientation meetings have started being scheduled
- 5 households have/are in the process of being relocated from Heritage Park



RELOCATION RECAP

Do you qualify for assistance?

- ✓ I am in the United States legally.
- ✓ I am listed on a Heritage Park lease agreement.
- ✓ I have made my rent payments as scheduled or am in a repayment agreement with RHA.
- ✓ I am not being evicted.

What assistance is being provided?

- ✓ Relocation funds to help pay for your move.
- ✓ Replacement housing through public housing or another program.
- ✓ Individualized housing counseling and advice.
- ✓ The right to return to the new Heritage Park.



RELOCATION FUND CHOICES

RHA will provide relocating residents with funds to put towards moving. Moving funds can be:

1) A fixed amount based on your bedroom size.

2) Or your actual reasonable moving costs.

- Residents will have to keep up with budgeting and receipts for this option.

RHA Public Housing

- 0-5 bedrooms
- Any RHA public housing or incentive property
- RHA remains your landlord
- Your deposit will automatically be applied to your new account
- No additional applications needed

Housing Choice Voucher

- Would need to apply to the Section 8 HCV program
- Need a voucher to be issued
- You will be responsible for finding your own landlord
- Voucher could be ported outside of Wake County if desired

REPLACEMENT HOUSING

RAD Project Based Voucher

- Would need to apply to the RAD/PBV program
- Need to go through Section 8 orientation
- You would be assigned to a RAD property managed by RHA staff
- Your deposit will automatically be applied to your new account

Project Based Voucher

- Would need to apply to the PBV program
- Need to go through Section 8 orientation
- You would be assigned to a unit with a PBV already in place
- The voucher stays with the unit if you decide to relocate later

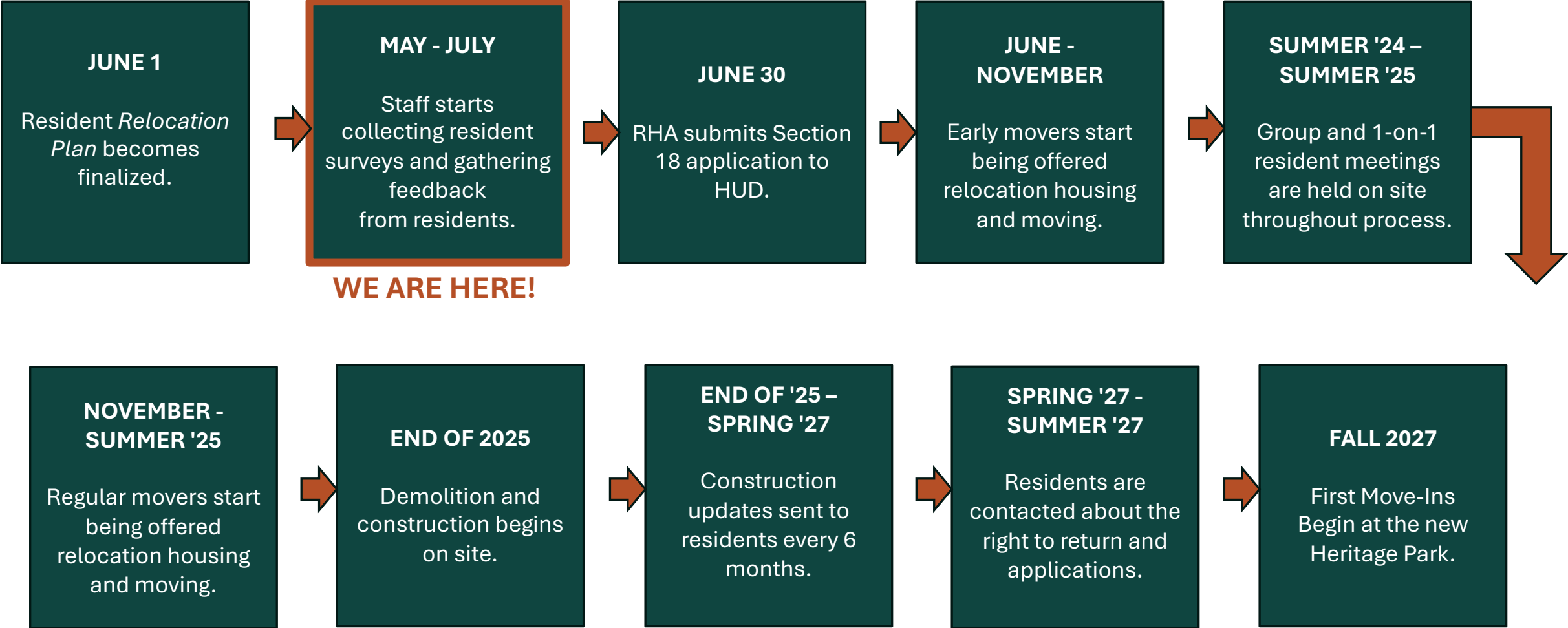


NEXT STEPS

Residents will be directed to:

- Complete your resident survey.
- Submit a Section 8 application with all paperwork *if* you are interested in a voucher.
 - *No need to apply for another public housing property*
- Wait to be contacted by RHA staff
 - We will work with you one-on-one about your preferences, needs, and future housing.
